GENERAL VESTING DECLARATION

THIS GENERAL VESTING DECLARATION is executed on the by Hirwaun Power Limited (company number 08190283) (the "Authority").

2020

WHEREAS:-

- (1) On 23 July 2015 an order entitled the Hirwaun Generating Station Order 2015 (SI 2015/1574) ("the Order") was made by Secretary of State for Energy and Climate Change under the powers conferred on her by the Planning Act 2008 authorising the Authority to acquire the land and new rights over land specified in the Schedule hereto. Article 22 of the Order provides for the application, with modifications (as identified in Article 22), of the Compulsory Purchase (Vesting Declarations) Act 1981 ("the Act") to the Order. The Act prescribes vesting procedures for land subject to powers of compulsory acquisition under the Development Consent Order.
- (2) A compulsory acquisition notice was first published in accordance with section 134 of the Planning Act 2008 on 31 July 2015.
- (3) A subsequent notice was given on 9 May 2020 before the service of any notice to treat in respect of any of the land described in the Schedule hereto and included the particulars specified in section 3(3) of the Act.
- (4) The notice referred to in (3) above did not specify any period longer than two months beginning with the date of its first publication as the period before the end of which this general vesting declaration could not be executed.

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on them by section 4 of the Act, the Authority hereby declare:-

- 1. Save insofar that they comprise or affect interests of Excluded Persons, the land, the Vested Rights and the Vested Restrictions described in column 4 of the Schedule hereto (being part of the land authorised to be acquired by the Order) and more particularly delineated by pink colouring, pink colouring and red hatching, blue colouring and red edging on the plans annexed hereto, together with the right to enter upon and take possession of the land, shall vest in the Authority as from the end of the period of 28 days from the date on which the service of notices required by section 6 of the Act is completed.
- 2. Each Vested Right and Vested Restriction shall so vest in and be exercisable or enforceable (as appropriate) by the Authority for the benefit of each and every part of the Authorised Development and Plot 10 and Plot 11 and the corporeal and incorporeal property comprised in the business undertaking of the Authority (but excluding the WPD Land) to the intent that the Vested Rights may be exercised and Vested Restrictions imposed by both the Authority and by its successors in title and assigns of the whole or any part of such property whether it is comprised in the business undertaking of the Authority or the business undertaking of any successor in title or assign and for the purposes of the construction, installation, operation, maintenance and decommissioning thereof.
- In this Declaration wherever the context permits:
 - 3.1.1 the headings are for convenience only and do not affect the interpretation of this Declaration;
 - 3.1.2 the capitalised terms appearing in this Declaration (including the Schedule) have the respective meanings assigned to them in the Schedule;
 - 3.1.3 reference to any statute or section of any statute includes a reference to any statutory amendments, modification or re-enactment thereof for the time being in force and to every instrument, order, direction, regulation, bye-law, commission, licence, consent, condition, scheme or other such matter made under or pursuant to statute;

- 3.1.4 words importing the singular include the plural and vice versa and wording importing gender includes any other gender;
- 3.1.5 references to persons includes persons firms and companies;
- 3.1.6 the word 'including' means including but without limitation;
- 3.1.7 the words 'in particular' means in particular but without prejudice to the generality of the preceding wording;
- 3.1.8 references to the Schedule are to the Schedule of this Declaration.
- 4. The Authority hereby requests the Chief Land Registrar to note the Vested Rights and Vested Restrictions acquired by the Authority by this Declaration in relation to a particular Plot in the Charges Register of each Registered Title relating to that Plot as soon as possible following the Vesting Date.
- 5. The Authority hereby requests the Chief Land Registrar to note the benefit of the Vested Rights and Vested Restrictions acquired by the Authority by this Declaration on title number CYM769632 (but excluding the WPD Land) and the land shown on Plan 3 and any other property acquired by the Authority for the purposes of or in connection with the Authorised Development or the Gas Pipeline.
- 6. The Authority hereby requests the Chief Land Registrar to note the acquisition of the mines and minerals acquired by the Authority by this Declaration in relation to a particular Plot in the appropriate Registers of each Registered Title relating to that Plot as soon as possible following the Vesting Date.

SCHEDULE

In this Declaration:

"Authorised Development" means the development authorised by the Order;

"Excluded Persons" means all and any of the persons listed in the Schedule and (in relation to the relevant Plot) those persons (if any) listed in the column 5 of the Schedule

"Gas Pipeline" means a high pressure gas pipeline up to 250mm nominal bore, telecommunications, other ancillary apparatus and any other works as necessary;

"Registered Title" means the registered title of the Plot and which is listed in the column 3 of the Schedule;

"Plan 1" means the plan annexed to this Declaration and labelled Drawing No: HPL Power Generation Plant Land Plan Revision: v3;

"Plan 2" means the plan annexed to this Declaration and labelled Drawing No: HPL Gas Connection Land Plan Revision: v3;

"Plan 3" means the plan annexed to this Declaration and labelled Drawing No: J0024759-20-03;

"Plan 4" means the plan annexed to this Declaration and labelled Drawing No: 34nt3162494 CF4;

"Plan 5" means the plan annexed to this Declaration and labelled Drawing No: 34nt3198145;

"Plot" means a plot of land with the number specified in column 1 of the Schedule, described in column 2 of the Schedule and shown on Plan 1, Plan 2 or Plan 3;

"Vested Restrictions" means restrictions on erecting buildings or structures, altering ground levels, planting trees or carrying out operations or actions which may obstruct, interrupt, or interfere with the exercise of the Vested Rights;

"Vested Rights" means the right for the Authority and all persons authorised on its behalf:

- (a) to enter on foot, with or without vehicles, plant and machinery for all purposes in connection with the laying, installation, use and maintenance of a Gas Pipeline together with the right to install, retain, use, maintain, inspect, repair, adjust, alter, remove, refurbish, reconstruct, replace and improve the Gas Pipeline; and
- (b) in respect of Plots 2_GR, 3_GR, 4_GR, 5_GR, 6_GR, 7_GR, 8_GR and 9_GR only, to construct and maintain a permanent means of access;

"Vesting Date" means the date 28 days after the later of (a) the date of this Declaration and (b) the date on which the service of notices required by section 6 of the 1981 Act is completed; and

"WPD Land" means the land shown coloured pink on Plan 4 and coloured pink on Plan 5.
