Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- Our ambition is to become carbon negative by 2030 (scope 1 and 2).
- We are committed to the Science Based Targets initiative and have submitted the following targets for validation: "Drax Group plc commits to reducing its scope 1 and 2 emissions by 42% and its scope 3 emissions by 42% by 2030 from a 2020 baseline (excluding emissions from downstream leased assets)."

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented:

- Since 2012, Drax Group has reduced its scope 1 and 2 carbon emissions by >85%. We have converted 4 of the 6 generating units at Drax Power Station to biomass, from coal.
- Our UK Generation sites are certified through their respective management systems to ISO 14001:2015 and subject to regular external audit.
- We are committed to the Science Based Targets initiative and have submitted the following targets for validation: "Drax Group plc commits to reducing its scope 1 and 2 emissions by 42% and its scope 3 emissions by 42% by 2030 from a 2020 baseline (excluding emissions from downstream leased assets)."

In the future we hope to implement further measures such as:

 We are developing options for bioenergy with carbon capture and storage (BECCS). Subject to the right government support, the first BECCS unit at Drax Power Station could be operational in 2027 with a second in 2030, permanently removing at least 8 million tonnes of CO2 from the atmosphere each year.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.

This Carbon Reduction Plan has been reviewed and signed off by the Drax Group plc Executive Committee and has been presented to the Board and received their endorsement.
