The Gas Connection will be in the form of a new above ground installation (AGI) and underground gas connection. This is to bring natural gas to the Abergelli Power Project from the National Gas Transmission System. Gas will be transported at a suitable rate and pressure to produce up to 299 Megawatt (MW) when the Power Station is in use. The AGI will comprise a Minimum Offtake Connection (MOC) facility, which will be owned by National Grid; and a Pipeline Inspection Gauge (PIG) Trap Facility (PTF), which will be owned by APL. Please refer to the accompanying Planning Design and Access Statement for further details on the proposed development.
