### The Hirwaun Generating Station (Amendment) Order

*Made* - - - - - \*\*\*  
*Coming into force* - - - - - \*\*\*

An application has been made, under paragraph 2 of Schedule 6 to the Planning Act 2008(a), to the Secretary of State in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011(b) for a non-material change to the Hirwaun Generating Station Order 2015(c).

The Secretary of State, having considered the application, and having consulted in accordance with regulation 7(1) of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011(d), has decided to make this Order amending the Hirwaun Generating Station Order 2015.

Accordingly, the Secretary of State, in exercise of the powers conferred by paragraphs 2(1) and (9) of Schedule 6 to the Planning Act 2008, makes the following Order—

#### Citation and commencement

1. This Order may be cited as the Hirwaun Generating Station (Amendment) Order 201[X] and comes into force on [X] 201[X].

#### Amendment to the Hirwaun Generating Station Order 2015

2. The Hirwaun Generating Station Order 2015 (“the 2015 Order”) is amended in accordance with this Order.

#### Amendment to Article 2

3. In article 2(1) (interpretation) of the 2015 Order in the definition of “the works plans” substitute “revision 4” for “revision 3”.

#### Amendments to Schedule 1 (authorised development)

4. Schedule 1 (authorised development) of the 2015 Order is amended as follows—

(a) 2008 c. 29. Paragraph 2 was amended by paragraph 4 of Schedule 8 to the Marine and Coastal Access Act 2009 (c. 23), by paragraphs 1 and 72 of Schedule 13 to the Localism Act 2011 (c. 20), and by section 28 of the Infrastructure Act 2015 (c. 7). There are other amendments to the Act that are not relevant to this Order.  
(b) S.I. 2011/2055, as amended by S.I. 2012/635 and S.I. 2015/760.  
(c) S.I. 2015/1574, as amended by S.I. 2015/2070.  
(d) S.I. 2011/2055, as amended by S.I. 2012/635 and 2015/760.

- (a) in Numbered work 2B(e), for “black start diesel generator” substitute “3 black start diesel generators where one gas turbine generator is constructed and 1 black start diesel generator where two, three, four or five gas turbine generators are constructed”; and
- (b) in Numbered work 2E(k), for “other ancillary equipment” substitute “other ancillary equipment including external fin fan cooler”.

**Amendments to Schedule 2 (requirements)**

5. Schedule 2 (requirements) of the 2015 Order is amended as follows—

- (a) in paragraph 4, Table 1 is replaced by Table 1 in Schedule 1 of this Order; and
- (b) in paragraph 4, Table 2 is replaced by Table 2 in Schedule 2 of this Order.

**Certification of revised plans**

6.—(1) The undertaker must, as soon as practicable after the making of this Order, submit copies of the plans listed in Schedule 1 to this Order to the Secretary of State for certification that they are true copies of those plans.

(2) A plan so certified by the Secretary of State is admissible in any proceedings as evidence of the contents of the document of which it is a copy.

(3) In paragraph (1), the “undertaker” has the same meaning as in article 2(1) of the 2015 Order.
